MINUTES OF THE SEPTEMBER 23, 2019**

SPECIAL PUBLIC SCHOOL BOARD MEETING 6:00 P.M.

The Board of School Trustees met for a special public meeting beginning at 6:00 P.M. at the Switzerland County Administration Building located at 1040 W. Main Street, Vevay, Indiana.

CALL TO ORDER / PLEDGE TO THE FLAG / MOMENT OF SILENCE:

Board President, Collier, called the special meeting to order, asked for the silencing of all communication devices and led those in attendance in the pledge to the flag followed by a moment of silence.

Interruption of Special Meeting to hold Public Hearings on CPF Plan, Bus Replacement Plan and 2019 Budget:

Board President, Collier interrupted the special meeting and opened the Capital

Projects Plan Hearing:

A Brief description of the 3-year Capital Projects Plan, (2020, 2021, 2022), was presented by Superintendent Hite. Hite explained that the plan contains a listing of all proposed projects that

are capital in nature that exceed \$10,000 that are expected to begin within the three years immediately following the year the plan was adopted. After the presentation, Board President, Collier, asked if there were any comments from the public. Hearing no further comments, motion to **CLOSE** the Public Hearing on the CPF Plan: Bennett / Second: Deck / Vote: Unanimous

Collier interrupted the special meeting and opened the Bus Replacement Plan Hearing:

The Bus Replacement Plan was summarized by Superintendent Hite. Hite explained that the anticipated number of buses the Corporation will need to purchase for each year of the plan, 2020-2024, is listed, as well as the estimated replacement costs. The plan is based upon the presumption that the minimum useful life of a school bus is not less than 12 years. Collier asked if there were any comments from the public. Collier interrupted the special meeting to Open 2020 Budget Hearing:

Add Swimming 7-12 (Summer) - Stipend \$400

Add Swimming MS Assistant - Stipend \$500

Baseball (Summer) Stipend increased from \$500 to \$750

Volleyball Girls JC – Stipend reduced from \$700 to \$400

Volleyball Girls SCE – Stipend reduced from \$700 to \$400

Volleyball Girls (Summer) – Stipend reduced from \$1,415 to \$1,200Add

September 23, 2019

Bowling stipend \$1,000

Changed name of Outdoor Club to Travel Club – Stipend \$443

Base Salary

Base salaries of teachers currently employed shall be set at \$1,000 increase.

Salary range for 2019-20 will increase from \$38,200-\$70,200 to \$38,200-\$71,200

Health Insurance

Health Insurance increased by 3%. To help offset the increase, Employer contribution will increase by 2%.
